2017 MAFCA National Tour

Welcome to the 2017 MAFCA National Tour. This tour will start at the **Estrella Warbird Air Museum** in Paso Robles, California. (ewarbirds.org) Registration opens on Sunday, September 24 at 12 PM. After you pick up your packet, you will have time to visit the vintage airplanes and the museum before the kick off dinner at 6:30 PM. We have a secured area, also located at the museum, in which to park your motor home and trailer before leaving to explore the beautiful California coast.

As we travel north on Highway 1, you will see **Hearst Castle**, Elephant Seals sunning themselves, and Ragged Point. Private tours have been scheduled at Hearst Castle, or you may want to drive into the sleepy town of Cambria to see local artist's wares and unique shops. **Due to a road closure, we will be returning to Paso Robles for Monday night.**

Driving one of the country's most scenic highways toward Carmel and Monterey will offer many vistas and photo opportunities. During your two-day stay in Monterey, you may visit the **Monterey Bay Aquarium** and Cannery Row. The quaint town of Carmel is filled with shopping, restaurants, bakeries, and a wonderful beach. You can also take a "Loop Drive" from Monterey through Carmel Valley and then catch Highway 69 back to town. Vineyards and wildlife such as, deer, wild boars, and peasant, are plentiful in the valley.

On your way north, Santa Cruz Natural Bridges, Monarch Butterflies, Half Moon Bay and Grey Whale Cove are spectacular. As we approach San Francisco, we will be going through Golden Gate Park then crossing the Golden Gate Bridge and arriving at San Rafael in Marin County.

After arriving in San Rafael, please check into your hotel and get ready to enjoy a wonderful evening with your Model A friends. We will be hosting our tour banquet at 6:30 PM on Thursday. Era clothing is always appreciated and makes the evening special.

Friday in **San Francisco** will be spectacular! A bus will pick you up at the host hotel and take you to the Sausalito Ferry Terminal. You will then take a chartered boat tour of from Sausalito, sailing under the Golden Gate, around Alcatraz Island and landing at Pier 39 at Fisherman's Warf. Things to do: Enjoy over 60 specialty shops at Pier 39, Ripley's Believe it or Not Museum, Ghirardelli Square, Take a trolley ride, Have lunch at one of the fantastic restaurants, or enjoy talented street performers. A final bus tour of San Francisco will return you back to the host hotel. San Francisco is not Model A friendly. Parking is hard to find and can be very expensive.

IN CONSIDERATION OF BEING PERMITTED TO VOLUNTARILY PARTICIPATE (AT MY REQUEST) IN THE EVENT OF MODEL A FORD CLUB OF AMERICA ("MAFCA"), ITS CHAPTERS, REGIONS AND/OR SPECIAL INTEREST GROUPS REFERRED TO BELOW ("EVENT"), I/We, THE UNDERSIGNED AGREE(S) TO THE FOLLOWING:

1. THE UNDERSIGNED HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE MAFCA, ITS CHAPTERS, REGIONS OR SPECIAL INTEREST GROUPS, THEIR EMPLOYEES, OFFICERS AND AGENTS ("Releasees") from all liability to the undersigned, his or her or their personal representatives, assigns, heirs, family members and next of kin ("**Releasors**") for any loss, damage, or claim therefor on account of *injury to the person or property of the Releasors, whether caused by any negligent act or omission or other fault of the Releasees or otherwise* while the undersigned is participating in the Event or using any of Releasees' facilities in connection with the Event.

2. THE RELEASORS HEREBY AGREE TO INDEMNIFY AND HOLD HARMLESS the Releasees from all liability, claims, demands, causes of action, charges, expenses, and attorney fees and all other costs resulting from my involvement in the Event whether caused by any negligent act or omission or other fault of the Releasees or otherwise.

3. THE RELEASORS HEREBY ASSUME FULL RESPONSIBILITY FOR AND RISK OF PERSONAL OR BODILY INJURY, DEATH OR PROPERTY DAMAGE while upon Releasee property or participating in the Event or using any Releasee facilities and/or equipment whether caused by any negligent act or omission or other fault of Releasees or otherwise.
